## Meet Anthony J. Barrette: Enhancing Our Team's Commitment to Community

### Answering the Call to Serve

Anthony's journey to Minot is as inspiring as his new role itself. Anthony was born and raised in the Riverside community of Southern California. He was attending Riverside Community College when the September 11th tragedy occurred. Inspired to join the military and serve his country, Anthony lost 65lbs and was able to join the Air Force on July 22, 2003. Anthony served as an Air Force Survival, Evasion, Resistance, Escape (SERE) Specialist in England, Germany, Korea, Afghanistan, Iraq, Syria, Jordan, Kuwait, U.A.E., and Qatar. According to the Air Force website, a SERE Specialist is the only Department of Defense specialty which is specifically trained, equipped, organized, and employed to conduct SERE operations for the duration of their career. ## PROJECT HIGHLIGHTS

### Acquisition Program

- Overall, the City of Minot has acquired 229 properties to date: 91 properties using NDR-CDBG funds and 138 properties using State Water Commission Funds; 8 properties included in the 91 NDR properties were partially funded with State Water Commission funds. These properties are needed for on-going or upcoming flood mitigation projects.
- Demolition activities for the year have been completed. Initially, work was slated to demolish five (5) acquired properties, but only three (3) properties were demolished. The remaining two (2) properties have structures which are slated for relocation which will be done in the next year. Auction and salvage of acquired properties continues. Overall, the City has demolished 163 properties, with 79 of those being funded by NDR-CDBG funds.

### Affordable Housing

- All apartments have been rehabilitated at Milton Young Towers (MYT); Minot Housing Authority (MHA) continues to backfill vacant apartments. Renovations of first floor common areas are almost complete. There are funds remaining in the project that MHA will use to renovate public restrooms on the first floor, as well as install energy-efficient ceiling tiles on the 15th floor.
- Construction of the Broadway Circle 17-unit affordable housing complex continues; the elevator shaft has been poured.

### Family Homeless Shelter

- Construction of the Broadway Circle 6-unit Family Homeless Shelter continues; the roof is being installed so that construction can continue during the winter. Construction is almost complete on the remodel of the multi-purpose commercial building, which will accommodate the community kitchen and food pantry.

### City Hall

- Operations are well underway at the new City Hall location; the City anticipates receiving the final payment request from the contractor before the end of the year.

### Center for Technical Education

- Progress continues on the construction of the CTE; recently, a temporary heating system was installed which will allow for temperature-sensitive work to proceed.
